**IN RESPONSE TO THE FEDERAL GOVERNMENT'S UNPRECEDENTED REMOVAL OF MORE THAN 20,000 WILD HORSES AND BURROS FROM THEIR HABITATS, THE ORGANIZATION INITIATED A NATIONAL ADVERTISING AND PUBLICITY CAMPAIGN TITLED "THERE'S A BETTER WAY." THIS CAMPAIGN FOCUSED ON THE CRUELTY OF HELICOPTER ROUNDUPS AND MASS CONFINEMENT OF WILD HORSES AND BURROS AND THE NEED FOR POLICIES TO PROTECT THESE NATIONAL SYMBOLS OF FREEDOM. THIS INITIATIVE EFFECTIVELY REDUCED POPULATION SIZES WITHOUT REMOVALS IN CRITICAL AREAS FACING ENCROACHING DEVELOPMENT, ADDRESSING PUBLIC SAFETY CONCERNS.
